Terms and Conditions for Licencing Images

This is a legal agreement between you, the User and Neill Watson who is the registered copyright holder of the images. Read this agreement in its entirety before you use the image(s).

- 1. Definitions** "Terms" Means the terms and conditions set out in this agreement and includes the terms of the License Confirmation Form(s).

"Image(s)" Means the Image(s) you have selected which is/are the subject of the License Confirmation details on the invoice.

"License to Use" Means the non-exclusive (unless otherwise stated in the License Confirmation Form) non- sublicencable right Neill Watson grants to you or your employer (if you are licencing on behalf of your employer) to use the Image you have selected.

"License Confirmation Form" Is the section of this agreement, which grants you limited reproduction rights over the Image(s) to which it refers.

"Reproduction" Includes any form of copying or publication of the whole or part of any Image whether by printing, slide projection (whether or not to an audience), electronic, digital or mechanical means, use as a reference by an artist or in an artist's illustration or by any other means. Reproduction further includes the copying or distortion or manipulation of the whole or part of the Image (for example, by computer, electronically, digitally by an artist or by any other means), even though the resulting Image may not appear to a reasonable person to be derived from the original Image.

"Release" Means an adult Release, property Release or any other release of a third party right, which it is necessary or desirable to obtain in respect of the Image.

"License Fee" Means any sum or sums actually received by Neill Watson from you in payment of the License to Use.
- 2. Contracting parties** The parties to this contract are Neill Watson and you. If you are entering into this agreement on behalf of your employer, the license granted and restrictions and limitations recited herein apply to your employer and to you as a representative of your employer. Should you cease working for your employer, your employer may continue to operate under this agreement and your rights under this agreement will be terminated.

4. Grant of License

- ii. In the event that the Image licensed to you is erroneously licensed to another entity for a conflicting use, as determined at Neill Watson sole discretion, or if Neill Watson is liable to you or your employer for any reason, then Neill Watson liability to you shall be limited to the sum invoiced and paid by you for the use of the particular Image involved.
- iii. Neill Watson shall not be liable for any loss or damage suffered by you or by any third party arising from use or reproduction of any Image or its caption. Damages for any other breach shall be limited to the license fee paid by you.
- iv. Neill Watson makes no other warranty, express or implied, including, without limitation, any implied warranties of merchantability or fitness for a particular purpose. v. 11. License Not Assignable Reproduction rights granted to you may not be assigned. They are personal to you or your employer.

12. Release Information

14. License Cancellation You may cancel the image license within seven working days from the date of the invoice without charge. If you cancel less than 30 working days after the invoice date, a cancellation fee of fifty (50%) percent of the invoice will be charged. After thirty working days, no cancellations will be accepted and the full amount of the invoice must be paid. Canceling the license revokes any right to publish the image in any shape or form. We do not count local holidays in calculating working days.

15. Interest on Overdue Invoices and Reasonable Recovery Costs If you are in the UK: Neill Watson will exercise our statutory right to claim interest and compensation for debt recovery costs under late payment legislation if we are not paid according to agreed terms. Interest will be charged at the Bank of England base rate plus 8%. For account holders in the EU: Neill Watson will exercise our statutory right to claim interest and compensation for debt recovery costs under late payment legislation if we are not paid according to agreed terms. Interest will be charged at the ECB base rate plus 7%. For account holders in the US and Rest of the World: Neill Watson will claim interest if we are not paid according to agreed terms, at the rate of the Bank of England base rate plus 8%.

17. Arbitration Any and all disputes arising out of, under or in connection with this contract, including, without limitation, the validity, interpretation, performance and breach hereof, shall be settled by arbitration in the English courts.

18. Miscellaneous Terms No variation of any of these Terms shall be effective unless agreed in writing by Neill Watson and you. No action of Neill Watson, other than an express written waiver, may be construed as a waiver of any clause of this agreement. In the event that Neill Watson waives any specific part of this agreement, such fact does not mean that any other part is waived. Should any clause of this agreement be found unenforceable, that will not affect any other
